5. At the request of the Ordering Party, not later than within 5 days of receipt of the request, I will provide the possibility of inspection and verification of the offered equipment in the territory of Poland or the countries of the European Union.

- 6) References or other documents proving that at least 3 (three) deliveries of vertical honing machines have been duly made within the last 3 (three) years.
- 7) A copy of the public liability policy with a minimum sum insured of PLN 1,000,000 (or the equivalent according to the average NBP exchange rate on the day preceding the deadline for submission of offers) for one and all events,
- 8) Technical specifications of the device
- 9) Device layout,
- 10) List of parts subject to normal wear and tear,
- 11) A detailed calculation of the components of the bid.
